At the end of last year the team diligently worked to prepare the event calendar of 2024, promising a mix of online and offline experiences in both France and in the Netherlands.

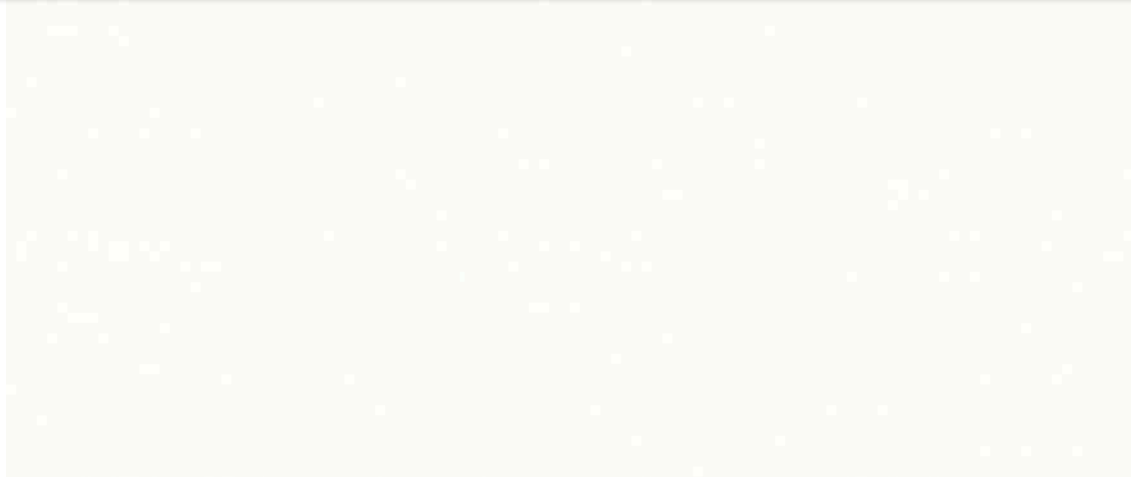
