All these initiatives aim continued growth and success for Dutch companies. Our goal is clear – to create an ecosystem where businesses flourish through purposeful connections!

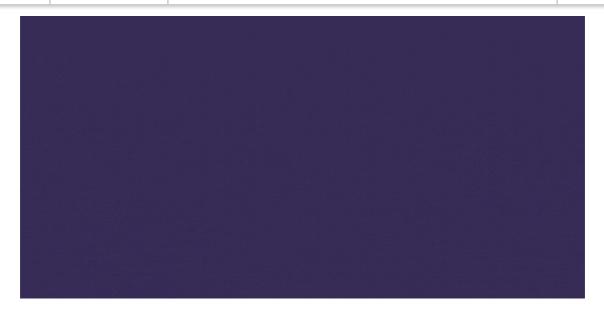

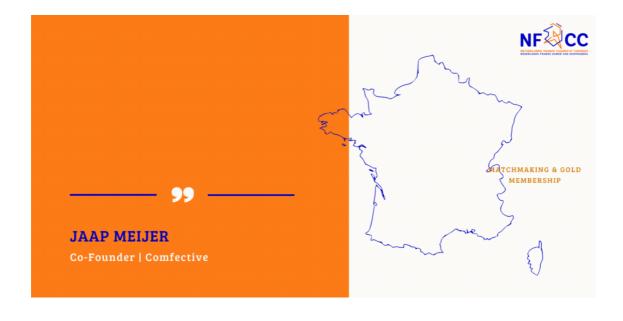
