normalisation of the situation on the supply chains and to aeronautical deliveries.

On the other hand, the inflationary environment and high interest rates are weighing heavily on domestic demand, which is shrinking. Business and household investment is falling, while household consumption is stagnating at a very low level. This does not bode well for the coming quarters. Indeed, business surveys indicate that the supply chain improvement effect is fading and that manufacturers are quite negative for the next few months, in line with the global economic slowdown. Exports are therefore likely to grow much more slowly in the coming quarters.

At the same time, consumer confidence is not recovering, unlike in other European countries, it remains at a historically low level, inflation continues to rise and to weigh on purchasing power, and households indicate that they want to save more in the coming months.

Consumption growth is therefore likely to remain very moderate, while investment is likely to remain very weak, in a context of interest rates that continue to rise. The outlook for the rest of the year therefore remains very bleak. We expect growth of 0.7% in 2023 and 0.7% in 2024, after 2.6% in 2022.
